Consider the award or rejection of contracts for highway construction and maintenance, and construction and rehabilitation of buildings, and consider the approval of an increase in funds for certain highway construction projects that received bids with cost overruns (Presentation)

These proposed minute orders contain information concerning the receipt of bids for highway improvement contracts and may include a proposal to increase funds from categories 2, 4 and/or 12 for certain projects. The department may reschedule receipt of bids for those projects where the commission rejects all bids or reassess funding proposals. Those bids and funding increases accepted by the commission will result in conditional contract awards to the low bidders. Contract award conditions may involve securing funding from other sources, the contractor's ability to satisfy federal DBE subcontracting requirements, or other requirements as outlined in the project bid proposal.

5. **Discussion Item**

Multimodal Freight Transportation Update (Presentation)

Staff will facilitate discussion on the assessment of the agency's role in multimodal freight transportation infrastructure in Texas.

6. **Design-Build Contract**

Bexar County - I-35 NEX South Project - Consider approving the selection of the proposer who submitted the best value proposal and the conditional award of a design-build contract and a corresponding capital maintenance contract to the selected proposer, for the design, construction and maintenance of the I-35 Northeast Expansion (NEX) South Project, consisting of non-tolled improvements along I-35 from approximately I-410 South to I-410 North, including transitions along I-35 from Petroleum Drive to I-410 South, and along the portion of I-410 South from the I-35/I-410 South Interchange to 0.3 miles north of Seguin Road/FM 78 in Bexar County, Texas. Additionally, consider approving an increase in funds for the I-35 NEX South Project if the price included in the proposal of the apparent best value proposer exceeds the funds authorized for the Project (MO) (Presentation)

On August 30, 2022, in Minute Order 116305, the commission authorized the department to issue a request for proposals to design, construct and maintain the I-35 Northeast Expansion South Project. The department has completed its review and evaluation of proposals and is presenting its best value recommendation to the commission. This minute order may include a proposal to increase funds from Category 2, 4, and 12.

7. Annual Highway Safety Plan

Consider approval of funding for the 2024 Highway Safety Plan (MO) (Presentation) The department develops and implements an annual Highway Safety Plan (HSP). Federal funds are allocated by the National Highway Traffic Safety Administration and are used for traffic safety grants identified in the HSP. The HSP organizes anticipated grants into focus-oriented program areas. This minute order lists the number of grants in each program area and the allocated amounts for Fiscal Year 2024.

8. Eminent Domain Proceedings

Various Counties - Consider the authorization of the filing of condemnation proceedings to acquire real property by eminent domain for non-controlled and controlled access highways (see attached itemized list) (MO)

Commission findings, determinations, and authorizations for the state, by motion made in accordance with Senate Bill 18 (82nd Legislature), to acquire by eminent domain, upon the payment of adequate and just compensation, various ownership interests in specific parcels of real property that are needed to develop or improve both non-controlled and controlled access state highways, to include requesting the state attorney general to bring and pursue condemnation suits relating to those specific parcels of real property described in the attached itemized list.

9. Routine Minute Orders and Reports

a. Donations to the Department

Various Districts - Consider the acknowledgment of donations with a value of \$500 or more, including donations of money, materials, services, or real property, that are made to the department for the purpose of assisting the department in carrying out its functions and duties or for improving access to or from a highway on the state highway system (see attached itemized list) (MO)

State statutes require the commission to acknowledge the acceptance of a gift to the department that is valued at \$500 or more. By the adoption of this minute order, the commission acknowledges the receipt and acceptance of the property specified in the minute order.

9. Routine Minute Orders and Reports (continued)

b. Reports

(1) Compliance Division Report

State law requires the commission to establish a compliance program, which must include a Compliance Division to oversee the program. The Compliance Division is responsible for acting to prevent and detect serious breaches of department policy, fraud, waste, and abuse of office, including any acts of criminal conduct within the department. The Compliance Division is required to provide a monthly report to the commission regarding investigations and a summary of information relating to trends and recommendations.

(2) Central Texas Turnpike System

Travis and Williamson Counties - Fiscal Year 2023 Central Texas Turnpike System Annual Inspection Report (Report)

The commission financed a portion of the costs of the Central Texas Turnpike System (System) with obligations issued pursuant to a trust indenture dated July 15, 2002. In accordance with Section 707 of the trust indenture, the commission has caused the general engineering consultant to make an inspection of the System and submit a report to the commission on or before the 90th day prior to the end of the fiscal year.

(3) Quarterly Investment Report

Quarterly Investment Report for all of the funds invested at the direction of the commission (Report)

This is a presentation of the quarterly investment report for the investment of: (1) funds held by the Bank of New York Mellon, as trustee, under the Indenture of Trust securing the Central Texas Turnpike System toll revenue obligations; (2) funds for the pre-paid TxTag account held by the Bank of New York Mellon, acting as custodian; (3) funds held by Amegy Bank, a Division of ZB, National Association, as trustee, under the Trust Agreement securing the I-35E Managed Lanes Project toll revenue obligations; and (4) funds held by U.S. Bank National Association, as trustee, under the Master Trust Agreement securing the SH 249 System toll revenue obligations.

- (4) **Grimes and Montgomery Counties** Quarterly Traffic and Revenue Report for the State Highway 249 System (Report)
 - The commission financed a portion of the costs of the State Highway 249 System (system) with obligations issued pursuant to a trust agreement. In accordance with Section 709 of the trust agreement, the commission is providing to the trustee, general engineering consultant, and traffic consultant a report of general information regarding the system for the preceding fiscal quarter. A copy of the report is being filed with the Municipal Securities Rulemaking Board through its Electronic Municipal Markets Access System.
- Travis and Williamson Counties Voluntary Quarterly Report of Actual Traffic and Toll Revenue for the Central Texas Turnpike System (Report) The commission financed a portion of the costs of the Central Texas Turnpike System (system) with obligations issued pursuant to a trust indenture. In accordance with Section 501(c) of the trust indenture, the commission covenants that for the first five full years of operation of the system, the commission will provide to the trustee a report showing the traffic and revenue of the system for the previous quarter. The commission may discontinue the reports because the revenues for the previous two years have been sufficient to meet the rate covenant; however, the commission has not exercised its option to discontinue the reports. A copy of the report is being filed with the trustee and the Municipal Securities Rulemaking Board through its Electronic Municipal Markets Access System.

9. Routine Minute Orders and Reports (continued)

- c. Highway Designations
 - (1) Angelina County In the cities of Burke and Diboll, consider designating US 59 along a new location and redesigning the old alignment of US 59 as Business US Highway 59-H on the state highway system (MO)

 This minute order (1) designates US 59 along a new location on the state highway system from the intersection of US 59 and FM 2108 southward to existing US 59, approximately 1.15 miles south of White Oak Creek, a total distance of approximately 7.5 miles; and (2) redesignates the old alignment of US 59 as Business US Highway 59-H from the intersection of US 59 and FM 2108 southward to approximately 1.15 miles south of White Oak Creek, a distance of approximately 6.7 miles.
 - (2) **Webb County** In the city of Laredo, consider designating SH 84 along a new location (MO)

 This minute order designates SH 84 along a new location on the state highway system from FM 1472 eastward to I-35, a distance of approximately 8.0 miles.
- d. **Designation of Access Control**

Tarrant County - SH 183, in the City of Bedford - Consider the redesignation of one location on the westbound frontage road of SH 183 at which access will be permitted to the abutting property (MO)

A landowner has requested the redesignation of the control-of-access line along its property abutting the westbound frontage road of SH 183 in Bedford, Texas. The redesignation will eliminate a current 35.01-foot break in the control-of-access line and create a proposed 54.00-foot break in the control-of-access line, which will allow the landowner to open one commercial driveway to the westbound frontage road of SH 183. The district has determined that access may be permitted at the designated location.

- e. Rail Clearance Deviations
 - **Gonzales County** Consider the approval of rail clearance deviations (MO) *This minute order authorizes approval of applications for rail clearance deviations, which are waivers from clearance provisions for structures over and alongside railway tracks.*
- f. Speed Zones

Various Counties - Consider the establishment or alteration of regulatory and construction speed zones on various sections of highways in the state (MO) *This minute order establishes or alters regulatory and construction speed zones on various sections of highways in the state.*

10. **Executive Session Pursuant to Government Code, Chapter 551 Section 551.071**Consultation with and advice from legal counsel regarding any item on this agenda, pending or contemplated litigation, or other legal matters.
