4. Contracts

Consider the award or rejection of contracts for highway construction and maintenance, and construction and rehabilitation of buildings, and consider the approval of an increase in funds for certain highway construction projects that received bids with cost overruns (Presentation)

These proposed minute orders contain information concerning the receipt of bids for highway improvement contracts and may include a proposal to increase funds from categories 2, 4 and/or 12 for certain projects. The department may reschedule receipt of bids for those projects where the commission rejects all bids or reassess funding proposals. Those bids and funding increases accepted by the commission will result in conditional contract awards to the low bidders. Contract award conditions may involve securing funding from other sources, the contractor's ability to satisfy federal DBE subcontracting requirements, or other requirements as outlined in the project bid proposal.

5. **Public Transportation**

a. **Various Counties** - Consider the award of additional federal funding to medium urban, small urban, and non-urban areas of the state for previously awarded projects that have requested additional funding in the department's 2023 Transportation Alternatives Set-Aside call for projects (MO)

The awards identified in this minute order reflect the allocation of additional federal Transportation Alternatives Set-Aside (TA) funds determined necessary for infrastructure projects previously awarded TA funding in population areas of 200,000 or less to construct on- and offroad bicycle and pedestrian accommodations, including sidewalks, shared use paths, and bicycle lanes.

b. **Various Counties** - Consider the award of state and federal funds to multiple entities for a variety of program-eligible purposes (MO)

The awards identified in this minute order reflect the allocation of fiscal year 2024 state funds to large urban, small urban, and rural transit districts; the allocation of federal Section 5304 funds to designated lead planning agencies; the allocation of federal Section 5310 first year awards to various entities for the biennial call for projects; the allocation of federal Section 5311 funds to rural transit districts; and the allocation of federal Section 5339(b) funds to Rolling Plains Management Corporation.

6. **State Infrastructure Bank** (Presentation)

Taylor County - City of Lawn - Consider final approval of a request from the city of Lawn for a State Infrastructure Bank loan in the amount of up to \$150,000 to pay for the costs of utility relocation necessary for a non-tolled on-system project to make bridge repairs on FM 604 in Taylor County, Texas (MO)

The city of Lawn (city) will secure the loan with a pledge of ad-valorem tax revenues and surplus utility system revenues. The loan will be used to pay the city's costs associated with utility relocation necessary for a non-tolled on-system project to make bridge repairs on FM 604 in Taylor County, Texas.

7. Eminent Domain Proceedings

Various Counties - Consider the authorization of the filing of condemnation proceedings to acquire real property by eminent domain for non-controlled and controlled access highways (see attached itemized list) (MO)

Commission findings, determinations, and authorizations for the state, by motion made in accordance with Senate Bill 18 (82nd Legislature), to acquire by eminent domain, upon the payment of adequate and just compensation, various ownership interests in specific parcels of real property that are needed to develop or improve both non-controlled and controlled access state highways, to include requesting the state attorney general to bring and pursue condemnation suits relating to those specific parcels of real property described in the attached itemized list.

8. Routine Minute Orders and Reports

a. **Donations to the Department**

Various Districts - Consider the acknowledgment of donations with a value of \$500 or more, including donations of money, materials, services, or real property, that are made to the department for the purpose of assisting the department in carrying out its functions and duties or for improving access to or from a highway on the state highway system (see attached itemized list) (MO)

State statutes require the commission to acknowledge the acceptance of a gift to the department that is valued at \$500 or more. By the adoption of this minute order, the commission acknowledges the receipt and acceptance of the property specified in the minute order.

8. Routine Minute Orders and Reports (continued)

b. Real Estate Dispositions

The commission must approve the sales, transfers, and exchanges of state rights of way and other real properties that are no longer needed for a state highway purpose. It must also approve, accept, and acknowledge donations to the state of real property that is valued at \$500 or more.

Travis County - FM 969 - Consider an easement release to the underlying fee owner (MO)

The district has determined that the easement is no longer needed for highway purposes. The easement may be released to the underlying fee owner.

c. Reports

(1) Compliance Division Report

State law requires the commission to establish a compliance program, which must include a Compliance Division to oversee the program. The Compliance Division is responsible for acting to prevent and detect serious breaches of department policy, fraud, waste, and abuse of office, including any acts of criminal conduct within the department. The Compliance Division is required to provide a monthly report to the commission regarding investigations and a summary of information relating to trends and recommendations.

(2) Letting Allocation Status Report

Quarterly status report on the FY2023-24 letting allocation, the actual allocation utilized through the quarter, and proposed remaining highway maintenance and construction contract letting for the fiscal year (Report)

This report will provide the current overall allocation status, by district and metropolitan planning organization, of the FY 2023-24 letting allocation and will also provide the anticipated effect on the letting allocation of remaining proposed highway maintenance and construction letting.

(3) Quarterly Cash Report

State Highway Fund 6 Report Quarterly report on FY 2023 State Highway Fund 6 cash status (Report)

This report updates the commission on the year-to-date cash balance and activity of Fund 6. The report will include original projections and actual revenues/inflows and expenditures/outflows on a cash basis.

d. Rail Clearance Deviations

- (1) **Harris County** Consider the approval of rail clearance deviations (MO) This minute order authorizes approval of applications for rail clearance deviations, which are waivers from clearance provisions for structures over and alongside railway tracks.
- (2) **Travis County** Consider the approval of rail clearance deviations (MO)

 This minute order authorizes approval of applications for rail clearance deviations,
 which are waivers from clearance provisions for structures over and alongside railway tracks.

e. Designation of Access Control

Van Zandt County - I-20, in the City of Canton - Consider the designation of two locations along I-20 at which access will be permitted to the abutting property (MO) The landowner has requested the designation of two breaks in the control-of-access line which will allow the abutting landowner to open two driveways: one for ingress and egress to and from the I-20 westbound exit ramp to SH 19 and one for ingress and egress to and from the future westbound frontage road. The district has determined that access may be permitted at the designated location.

f. Speed Zones

Various Counties - Consider the establishment or alteration of regulatory and construction speed zones on various sections of highways in the state (MO) *This minute order establishes or alters regulatory and construction speed zones on various sections of highways in the state.*
