These proposed minute orders contain information concerning the receipt of bids for highway improvement contracts. The department may reschedule receipt of bids for those projects where the commission rejects all bids. Those bids accepted by the commission will result in conditional contract awards to the low bidders. Contract award conditions may involve securing funding from other sources, the contractor's ability to satisfy federal DBE subcontracting requirements, or other requirements as outlined in the project bid proposal.

5. **Promulgation of Administrative Rules** Under Title 43, Texas Administrative Code, and the Administrative Procedures Act, Government Code, Chapter 2001:

#### a. Rule Proposal

# **Chapter 2 - Environmental Review of Transportation Projects**

Repeal of §2.132 (Gulf Intracoastal Waterway Projects) and replacement with proposed new §§2.351-2.364 (Gulf Intracoastal Waterway Projects) (MO)

The purpose of this rulemaking is to reorganize and clarify the rules of the Texas Transportation Commission (commission) concerning the requirements for state participation in dredge disposal plans and projects for the beneficial use of dredged materials related to the Gulf Intracoastal Waterway. The rulemaking also removes references in the rules to the Gulf Intracoastal Waterway Advisory Committee, which has been abolished.

#### b. Rule Adoption

#### **Chapter 1 - Management**

Amendments to §1.84 and §1.88 (Advisory Committees) (MO)

The rule amendments extend the sunset dates for statutory and department advisory committees and add provisions relating to the Advanced Air Mobility Advisory Committee, which was established by S.B. 2144, 88th Legislature.

# 6. Advisory Committee Appointment

**Advanced Air Mobility Committee** - Consider the appointment of members to the Advanced Air Mobility Advisory Committee (MO)

As required by S.B. 2144 of the 88th Texas Legislature, "the commission shall appoint an advisory committee to assess current state law and any potential changes to state law that are needed to facilitate the development of advanced air mobility technology in this state." This minute order approves the appointment of all members of the advisory committee, which will be abolished no later than January 1, 2025, as required by statute.

#### 7. Public Transportation Alternatives Program

**Various counties** - Consider the award of federal funding to local entities for projects submitted in the department's 2023 Transportation Alternatives Set-Aside (TA) call for projects (MO) (Presentation)

The awards identified in this minute order reflect the allocation of federal Transportation Alternatives Set-Aside funds for selected infrastructure projects throughout the state to construct a variety of alternative transportation projects, including ADA/pedestrian infrastructure, on- and off-street bikeways, shared use paths, and active transportation planning documents.

# 8. **Public Transportation**

- a. **Various counties** Consider the award of federal §5310 funds to two transit providers for program-eligible projects (MO)
  - The awards identified in this minute order reflect an allocation of §5310 funds awards to the Capital Area Rural Transportation System and to Mounting Horizons, Inc., based on applications submitted for the biennial call for projects.
- b. **Various counties** Consider the award of state funds to rural transit providers for service expansion eligible projects (MO)
  - The awards identified in this minute order reflect an allocation of State Funds awards to rural transit districts for service expansion projects.

#### 9. **Aviation**

**Various Counties** - Consider the award of federal non-primary entitlement grant funding, federal apportionment grant funding and state grant funding for airport improvement projects at various locations (MO)

Federal law authorizes the award of federal non-primary entitlement grant funding and federal apportionment grant funding to preserve and improve the state's general aviation system. State law authorizes the award of state grant funding for capital improvement projects.

#### 10. Finance

**El Paso County - Camino Real Regional Mobility Authority -** Consider approval of the conversion of the Loop 375 Border Highway West Extension project to a non-tolled state highway, the removal of the toll project designation for the project, and cancellation of the Camino Real Regional Mobility Authority's obligation to repay financial assistance from the department (MO)

This minute order will authorize the conversion of the Loop 375 Border Highway West Extension project to a non-tolled state highway and remove the toll project designation. In addition, the minute order cancels the Camino Real Regional Mobility Authority's obligation to repay financial assistance from the department.

#### 11. Water Supply Service Corporation Utility Relocation Reimbursement

**San Jacinto & Liberty Counties** - Consider the approval of a request from the Mercy Water Supply Corporation to make the relocation of the Mercy Water Supply Corporation's utility facilities required by the US 59 highway improvement project an expense of the state under Transportation Code §203.092(a-4) (MO)

Texas Administrative Code, Chapter 21, Subchapter B, Rule 21.25 sets forth the requirements for a utility to qualify for reimbursement under this program. Payment for this relocation will not cause the department to exceed \$10 million in any fiscal year. The utility is a water supply service corporation with a financial condition that prevents the utility from being able to pay the cost in full or part or, if paid at that time, the payment would adversely affect the utility's ability to operate or provide essential services to its customers. The utility is a water supply service corporation operating under Chapter 67, Water Code. The utility is unable to receive a state infrastructure bank loan to finance the cost of the relocation and is otherwise unable to finance that cost.

# 12. Eminent Domain Proceedings

Various Counties - Consider the authorization of the filing of condemnation proceedings to acquire real property by eminent domain for non-controlled and controlled access highways (see attached itemized list) (MO)

Commission findings, determinations, and authorizations for the state, by motion made in accordance with Senate Bill 18 (82nd Legislature), to acquire by eminent domain, upon the payment of adequate and just compensation, various ownership interests in specific parcels of real property that are needed to develop or improve both non-controlled and controlled access state highways, to include requesting the state attorney general to bring and pursue condemnation suits relating to those specific parcels of real property described in the attached itemized list.

# 13. Routine Minute Orders and Reports

# a. **Donations to the Department**

**Various Districts** - Consider the acknowledgment of donations with a value of \$500 or more, including donations of money, materials, services, or real property, that are made to the department for the purpose of assisting the department in carrying out its functions and duties or for improving access to or from a highway on the state highway system (see attached itemized list) (MO)

State statutes require the commission to acknowledge the acceptance of a gift to the department that is valued at \$500 or more. By the adoption of this minute order, the commission acknowledges the receipt and acceptance of the property specified in the minute order.

#### 13. Routine Minute Orders and Reports (continued)

#### b. Real Estate Dispositions

The commission must approve the sales, transfers, and exchanges of state rights of way and other real properties that are no longer needed for a state highway purpose. It must also approve, accept, and acknowledge donations to the state of real property that is valued at \$500 or more.

- (1) **Bexar County** SH 151 Consider the conveyance of real property for mitigation of adverse environmental impacts (MO)

  The district has determined that the land is no longer needed for highway purposes. The Texas Department of Transportation may transfer any interest in real property to an appropriate public agency or private entity, as authorized by the regulatory authority that requires the mitigation, with or without monetary consideration, if the property is used or is proposed to be used for mitigation purposes.
- (2) **Burnet County** FM 2147 Consider the exchange of a drainage channel easement as part of a transaction to acquire a drainage channel easement needed for a state highway purpose (MO)

  The district has determined that the easement to be released by the state in the exchange

The district has determined that the easement to be released by the state in the exchange is no longer needed for a state highway purpose. The commission may authorize the executive director to execute an instrument exchanging an interest in real property acquired but not needed for a highway purpose as whole or partial consideration for another interest in real property needed for a state highway purpose.

- (3) **Chambers County** SH 61 Consider the conveyance of right of way to Chambers County, Texas (MO)

  The district has determined that the right of way is no longer needed for highway purposes. The right of way may be conveyed to the county.
- (4) **Collin County** SH 5 Consider the sale of real property interests (easements) to a governmental entity with the authority to condemn the property (MO) *The district has determined that easements to be encumbering the land are no longer needed for highway purposes. A governmental entity with the authority to condemn the property has requested to purchase the easements, and they may be sold to the requester.*
- (5) **Dallas County** I-35E Consider the sale of real property to a governmental entity with the authority to condemn the property (MO)

  The district has determined that the land is no longer needed for highway purposes. A governmental entity with the authority to condemn the property has requested to purchase the land, and it may be sold to the requester.
- (6) **Dallas County** I-45 Consider the sale of right of way to an abutting landowner (MO)

The district has determined that the land is no longer needed for highway purposes. An abutting landowner has requested to purchase the land, and it may be sold to the requester.

- (7) **Tarrant County** SH 121 Consider the sale of right of way to an abutting landowner (MO)
  - The district has determined that the land is no longer needed for highway purposes. An abutting landowner has requested to purchase the land, and it may be sold to the requester.
- (8) **Washington County** SH 105 Consider the sale of right of way to an abutting landowner (MO)

The district has determined that the land is no longer needed for highway purposes. An abutting landowner has requested to purchase the land, and it may be sold to the requester.

#### 13. Routine Minute Orders and Reports (continued)

#### c. Reports

#### (1) Compliance Division Report

State law requires the commission to establish a compliance program, which must include a Compliance Division to oversee the program. The Compliance Division is responsible for acting to prevent and detect serious breaches of department policy, fraud, waste, and abuse of office, including any acts of criminal conduct within the department. The Compliance Division is required to provide a monthly report to the commission regarding investigations and a summary of information relating to trends and recommendations.

#### (2) Letting Allocation Status Report

Quarterly status report on the FY2023-24 letting allocation, the actual allocation utilized through the quarter, and proposed remaining highway maintenance and construction contract letting for the fiscal year (Report)

This report will provide the current overall allocation status, by district and metropolitan planning organization, of the FY 2023-24 letting allocation and will also provide the anticipated effect on the letting allocation of remaining proposed highway maintenance and construction letting.

#### (3) State Highway Fund 6 Report

Quarterly report on FY 2023 State Highway Fund 6 cash status (Report) This report updates the commission on the year-to-date cash balance and activity of Fund 6. The report will include original projections and actual revenues/inflows and expenditures/outflows on a cash basis.

#### (4) CTTS Annual Toll Rate Escalation Report

**Travis and Williamson Counties** - Report of the toll rate escalation percentage and escalated toll rates for the Central Texas Turnpike System, consisting of the SH 130 (Segments 1-4), SH 45N, Loop 1 (from FM 734 to SH 45N), and SH 45SE project elements (Report)

This report provides the toll rate escalation percentage increase and the annual escalated toll rates for the Central Texas Turnpike System. The commission's Toll Rate Escalation Policy requires that a percentage increase in the toll rates will be determined and reported to the commission each year at or before the commission's October meeting, and that the percentage increase in the toll rates will be effective automatically on January 1 of the next calendar year and implemented by the executive director unless the commission affirmatively votes prior to January 1 to modify the percentage.

#### (5) Grand Parkway (SH 99) Annual Toll Rate Escalation Report

Various Counties - Report of the toll rate escalation percentage and escalated toll rates for portions of SH 99 (Grand Parkway) consisting of the tolled portion of Segment D in Harris County, Segments E, F-1, F-2, G, H, I-1, and I-2 (Report) This report provides the toll rate escalation percentage increase and the annual escalated toll rates for the tolled portion of Grand Parkway Segment D in Harris County and for Segments E, F-1, F-2, G, H, I-1, and I-2. The commission's Toll Rate Escalation Policy requires that a percentage increase in the toll rates will be determined and reported to the commission each year at or before the commission's October meeting, and that the percentage increase in the toll rates will be effective automatically on January 1 of the next calendar year unless the commission affirmatively elects prior to January 1 to modify the percentage.

#### c. Reports (continued)

#### (6) SH 249 Annual Toll Rate Escalation Report

**Grimes and Montgomery Counties** - Report of the toll rate escalation percentage and escalated toll rates for the SH 249 System, comprised of Segment 1 of the SH 249 project extending SH 249 from FM 1774 in Pinehurst, Texas to FM 1774 in Todd Mission, Texas (Report)

This report provides the toll rate escalation percentage increase and the annual escalated toll rates for the SH 249 System in Grimes and Montgomery counties. The commission's Toll Rate Escalation Policy requires that a percentage increase in the toll rates will be determined and reported to the commission each year at or before the commission's October meeting, and that the percentage increase in the toll rates will be effective automatically on January 1 of the next calendar year and implemented by the executive director unless the commission affirmatively votes prior to January 1 to modify the percentage.

#### d. Finance

**Chambers County** - Consider establishing initial toll rates for new tolling points associated with two ramps on Segment I-2 of the Grand Parkway (SH 99) at the intersection of Johnnie G. Jennings Drive (MO)

This minute order adopts the initial toll rates for new toll gantries on tolled entrance and exit ramps at the intersection of SH 99 Johnnie G. Jennings Drive (previously known as EW4), within Segment I-2 of the Grand Parkway project.

e. Consultation and Review - Department of Motor Vehicles, Chapter 219
Consultation on Department of Motor Vehicles rules regarding overweight/oversize vehicles (MO)

Transportation Code, § 623.195 requires that the Department of Motor Vehicles Board consult with the commission on the adoption of certain rules regarding overweight/oversize vehicle permits issued by Department of Motor Vehicles (DMV). Staff has reviewed the Chapter 219 rule changes proposed by the DMV Board. This minute order confirms the commission's consultation and review of the DMV proposed rules.

#### f. Highway Designation

Bell & Milam Counties - In the city of Rogers, consider designating US 190/SH 36 on a new location and redesignating a segment of US 190/SH 36 as BU 190-K (MO) This minute order (1) designates a segment of US 190/SH 36 on a new location on the state highway system from 1.1 miles east of Knob Hill Road in Bell County, southeastward around the north side of the city of Rogers, to west of County Road 104 in Milam County, a distance of approximately 5.5 miles; and (2) redesignates a segment of US 190/SH 36 as BU 190-K from 1.1 miles east of Knob Hill Road in Bell County, southeastward and through the city of Rogers, to west of County Road 104 in Milam County, a distance of approximately 4.9 miles.

#### g. Speed Zones

**Various Counties** - Consider the establishment or alteration of regulatory and construction speed zones on various sections of highways in the state (MO) *This minute order establishes or alters regulatory and construction speed zones on various sections of highways in the state.* 

14. **Executive Session** Pursuant to Government Code, Chapter 551 **Section 551.071** - Consultation with and advice from legal counsel regarding any item on this agenda, pending or contemplated litigation, or other legal matters.

**OPEN COMMENT PERIOD** - At the conclusion of all other agenda items, the commission will allow an open comment period, not to exceed one hour, to receive public comment on any other matter that is under the jurisdiction of the department. No action will be taken. Each speaker will be allowed a maximum of three minutes. Speakers must be signed up prior to the beginning of the open comment period.
